## Background

Candidate countries of the Western Balkans region are committed to joining the EU and engaged in the vital process of harmonization with the EU's legislative and strategic framework. In the agricultural and nature protection domain, this includes farming, rural development, food safety, veterinary and phytosanitary policy, biodiversity conservation, environmental protection and animal welfare.
